

Research Participant Privacy Collection Notice

1. Who We Are

The Council of the Queensland Institute of Medical Research, trading as QIMR Berghofer ("we," "us," or "our"), is committed to protecting your privacy in accordance with the Information Privacy Act 2009 (Qld). This notice outlines how we collect, use, store, and disclose your personal information as a participant in our research projects. For further details, please refer to our Privacy Policy.

2. Why We Collect Your Information

QIMR Berghofer collects personal information from research participants to conduct medical research, manage and administer research projects, comply with legal and ethical obligations, communicate with you about the research, and ensure the integrity and quality of our research activities.

3. Types of Personal Information We Collect

We may collect information such as your name, contact details, demographic information, health and medical history, responses to research questionnaires or interviews, biological samples, and any other information necessary for the research project.

4. How We Collect Information

Where possible, we collect personal information directly from you. In some cases, information may be collected from your healthcare providers, research collaborators, or from publicly available sources, but only with your consent or as permitted by law.

5. Legal Basis for Processing

We collect and use your information only where:

- You have provided informed consent to participate in the research;
- It is necessary to comply with legal or regulatory obligations; or
- It is required for purposes related to public interest in scientific research, subject to appropriate safeguards.

6. Disclosure of Information

We may share your information with:

- Research collaborators and service providers assisting with the project (e.g., laboratories, data analysts);
- Ethics committees and regulatory bodies (as required for research oversight);
- Government authorities (if required by law).

Where possible, information will be de-identified before sharing.

7. Overseas Transfers

[If applicable: Your information may be transferred to research collaborators or service providers in other countries. In such cases, we will ensure appropriate safeguards are in place to protect your privacy.]

8. Data Breach Notification

If a data breach occurs that is likely to cause harm, we will notify you and the Queensland Office of the Information Commissioner (OIC) as required by law.

9. Access and Correction

You have the right to:

- Request access to your personal information held by us;
- Request correction of any inaccurate or incomplete details.

10. Complaints
